1. Reference is made to your letter dated 3 October 1949, file RHE 200.2 (St. Avoird, DDDD-11-125), Subject: Reprocessing of Remains.

2. Comparison of the tooth chart, dated 25 July 1949, with the tooth chart, dated 10 December 1947, for Unknown X-6280 indicates that these charts were accomplished from two different sets of teeth. The chart accomplished on 10 December 1947 compares very favorably with Army dental records for 2/Lt. EDWARD J. LATIMER, O-776671. The laundry mark "X-0952" found on the clothing of the deceased (at the time designated X-6280) was in agreement with that of 2/Lt. LATIMER, whose enlisted serial number was 35340952. It appears apparent, therefore, that the remains reprocessed 25 July 1949 are not the same as those reprocessed 10 December 1947.

3. It is further noted that the bridge found with the remains of Unknown X-6433, at the time of original processing, corresponds to that recorded on Army dental records for Sgt. ROBERT E. MEAD, 38406902, identified by your Headquarters as the deceased previously designated Unknown X-6292.

4. Case History, attached to Reports of Burial for Unknowns X-6269, X-6292, X-6319, X-6416 and X-6574, states that only eleven (11) Unknowns were recovered from Brunenthal. Records of this office show thirteen (13) Unknowns recovered from Brunenthal as follows:
