1. Reference is made to Reports of Burial for Unknowns X-6740, 6741, 6885, 6893, 6908 and 6909 A, B St. Avold, France which your Headquarters associated with six (6) unidentified crew members from A/C 42-78322, MACR 7535.

2. Through a favorable comparison of dental charts, this office has ~~made~~ made the following individual associations:

X-6740	1st Lt. Leonard S. Cox	0-686412	
X-6741 A, B.	S/Sgt. James R. Adams	35176623	
X-6909 A, B.	S/Sgt Henry P. Egerton	32266886	(tooth chart 2)
X-6909 A, B.	S/Sgt. William H. Broderick	31108554	(tooth chart 1 & 3)

3. The records of this office indicate that X-6885 and 6893 St. Avold are the only remaining Unknowns disinterred from Lermoos, Austria where the remains of three identified crew members, of subject plane, Capt. Jack Faiver, T/Sgt. Edwin E. Nolen and S/Sgt. Ralph P. Schert, were recovered. It is believed that X-6885 and 6893 might be associated with 2nd Lt. Richard E. Thomas, O-1691619 and S/Sgt. Frank Ferrone, 16011071, the last of the six crew members to be accounted for.

4. In view of the foregoing, it is requested that these cases be re-investigated and if your Headquarters concurs with the association, that Board Findings be forwarded to this office via air mail.

5. OQMS Forms 371 with the latest dental information available to this office for the six unidentified crew members, are inclosed as an aid to identification.

6. A Congressional Inquiry has been received for S/Sgt Adams.
