Your latter has been forwarded to this office for reply relative to information concerning your brother, the lete Private First Class Morris Blattman.

At the outpreak of the war it became necessary to adopt the policy that the remains of our American toad overseas should not be returned to the United States until after the cassation of hostilities.

Now that Japan has been defeated immediate plans are being formulated with a view to returning to the next of kin the remains of their loved ones. 
