

Your letter to the War Department concerning your sons, the late Private Lee D. Hilburn, and the late Sergeant Ray W. Hilburn, has been referred to this office.

The official Report of Burial discloses that the remains of Private Lee B. Hilburn were interred in Plot F, Row 5, Grave 90, in the United States Military Cemetery, Henri-Chapelle, Belgium, located seven miles southwest of Auchen, Germany, five miles northwest of Eupen and eight miles east of Liege, both in Belgium.

It is with deep regret that you are advised that, up to the present time, information pertaining to the burial of the remains of Sergeant Hay W. Hilburn, has not been received in this office. Upon receipt of information you will be advised.

The American Graves Registration Service is rapidly transmorming American Military Cometeries into places of simple reverent beauty. The grounds and surrounding areas are being landscaped and trees, shrubs and flowers have been and are being planted therein. Currently, conditions abroad do not permit this office to make arrangements for the placing of flowers on individual graves. However, on special occasions, such as Memorial Day, Armistice Day, stc., all graves are individually and appropriately decorated with flowers and small American Flags.

This office regrets the delay in answering your letter and extends the sincere sympathy in the less of your sons.





All expenses associated with the return of your son will be borne by the United States Government until he reaches the city or town designated as his final resting place and full military honors and escorts will be afforded on all phases of the trip home. In addition, the Government will contribute \$50.00 toward the defrayment of any further expenses at the place of interment.

You will be reimbursed for the burial expense up to \$50.00 upon proper execution of the interment certificate. If funeral cost is \$112.00 as quoted in telephone conversation this date, the balance of \$62.00 must be borne by the family of the deceased.

If it is at all possible, it is suggested that you come to the Fort Worth Quartermaster Depot for a personal interview or telephone, 4-2261, Ext. 50, in regard to this matter. In the event that it is impracticable for you to visit the office or to telephone, we shall be happy to answer any further questions to the best of our ability through correspondence.
