I left my home in Sept 1944 and went to Weert, Holland where I stayed until the 22 December 14. When I returned to my home at Hoeve G 15 Nederweert, I saw two graves about 50 yards east of my home. A Dutch soldier told me that they were the graves of two Americans. He also told me that the Dutch RedCross of Weert, Holland made the graves on the 1st of December 1944. I did not know the names of the two soldiers buried there.
